

## How to Add Direct Deposit Details to Tenant Invoices & Statements

From Rest Professional Version 20, there is a system option to allow you to display Direct Deposit details for your Trust Account, on your Tenant invoices and statements.

To configure the Direct Deposit details on your Tenant invoices and statements, go to:

- Other > Utilities > System Options
- Statements Tabs
- Select the radio button for Direct Deposit
- Select OK/F12
